**34th Annual Meet in the Street  
Downtown Merchant Road Sale Application**

**Deadline: Friday, February 13, 2015**

**NOTE: This application is for merchants currently located in Downtown Wake Forest ONLY.**

**Merchant Road Sale Rules:** All items for sale must be original to your store. You must submit photos of what items or like items you plan to sell for review by the committee. Merchants must sell only the items listed on the application. No electrical outlets will be made available by the Wake Forest Area Chamber or the Meet in the Street Committee. Merchants selling food items may be subject to food vendor rules and a special permit may be required. Please contact Wake County Environmental Services for more information at 919.856.6609.

**Food Vendor Rules:** All food vendors are subject to inspection by Wake County Environmental Services and are required to submit a Temporary Food Establishment permit by Friday, March 20, 2015. Food vendors must obtain this permit to operate in Wake County. Call 919.856.6609 for more information and to obtain the appropriate forms. You must submit a menu and pricing with this application. You may sell only the food listed on your application as the committee selects a limited number of vendors and tries to ensure a variety of food for the festival. The Meet in the Street Committee reserves the right to assign, reassign or remove vendors from the festival for not complying with the rules.

The basic display booth space will be 10'x10' for participating merchants. (Booth space can be increased as requested if application received by the February 13th deadline). Merchants must provide their own setup, including tables, chairs and tents. Booths must be manned at all times and merchants are responsible for providing employees/volunteers for entire time that booth is set up. Please note: There is a possibility that your booth may not be right outside your business. Every attempt will be made to keep your booth as close as possible to your storefront.

**Applications:** Must be filled out completely and accompanied by the appropriate photos. Applications will not be processed without photos. No application will be accepted after the deadline. Qualifying applicants will be accepted based on availability.

*Inclement Weather: Meet in the Street is held rain or shine. In case of lightning, festival will be canceled. There is no rain date.*
