Non-Profit Vendor Application
Deadline: Friday, February 13, 2015**

NOTE: You MUST be a Chamber Member to submit this application. Non-profits that are not members that would like to participate in Meet in the Street can join the Chamber and participate, or apply as an art/craft vendor and sell handmade arts/crafts.

Non-Profit Vendor Rules: Non-profit booths can be Informational or Fundraising booths. Informational Booths must only provide materials about your non-profit. **You can not leave booth space to give out these materials or you will be asked to leave.** Fundraising Booths must provide an art/craft item in return for receiving money, or may provide an experience geared toward children in return for funds (i.e. game; no face painting). Fundraising Booths will receive preferred booth locations. The Meet in the Street Committee reserves the right to assign, reassign, or remove vendors for not complying with the rules.

Display Space: Booth space is 10'x10' for non-profit vendors. Vendors must provide all set up, including tables, extension cords, and tents if needed.

Applications: Must be filled out completely and accompanied by the appropriate photos with full payment. Applications will not be processed without photos or payment. No application will be accepted after the deadline. Qualifying applicants will be accepted based on availability of space.

Inclement Weather: Meet in the Street® is held rain or shine. In case of lightning, the festival will be canceled. No rain date.
