Application Deadline: Friday, February 12, 2016

**Arts & Crafts Vendor Rules:** All items for sale must be original and handcrafted. Commercially manufactured or kit items will not be accepted. You must submit photos of your art/craft for review. Photos may be submitted as hardcopies or emailed to corey@wakeforestchamber.org. You may sell only the items listed on your application. On the day of the festival, vendor booths will be inspected by the committee. Any vendor found selling commercially manufactured or kit items will be removed from the festival. Downtown merchants are exempt from the handmade requirement. The Meet In The Street Committee reserves the right to assign, reassign, or remove vendors from the festival for not complying with the rules.

**Display Space:** Booth space is 10'x10' for arts & crafts vendors. **Vendors must provide all set up**, including tables and tents if needed. Booth locations are determined by committee selection. White Street location is not guaranteed. Date application is submitted is a determining factor. Applications that come in after the deadline may not receive preferred location.

**Applications:** Must be filled out completely and accompanied by the appropriate photos with full payment. Photos can be emailed to corey@wakeforestchamber.org or submitted as hardcopies. Applications will not be processed without photos or payment. Call for availability if it is after the application deadline. Qualifying applicants will be accepted based on availability of space.

*Inclement Weather: This event is held rain or shine. In case of lightning, festival will be canceled. There is no rain date.*
