NOTE TO PEDDLERS:

According to the Town of Wake Forest Ordinance Chapter 22: Parks & Recreation, Article I, Section 22-9: Selling, Peddling, etc. states:

It shall be unlawful for any person to engage in SOLICITING, PEDDLING, BEGGING OR SELLING goods or merchandise, or to sell, hawk or vend food or drinks within the parks unless written authority if given by the DIRECTOR of parks and recreation, and unless such selling, peddling, soliciting or begging is in accordance with other applicable provisions of the Code and state and local laws and regulations.
