### Important Information

Please review the following information before completing the Area Light Service Application.

The acceptance of this contract shall not be less than three (3) years for overhead service or not less than five (5) years for underground service and shall extend from year to year thereafter until terminated by the customer. Or, the customer may terminate the contract before the expiration of the initial contract by paying the Town of Wake Forest a sum of money equal to 40% of the bill which otherwise would have been rendered for the unexpired months of the initial contract period. The Town may require the customer to initially make a termination deposit which will not exceed the termination amount computed in accordance with the above paragraph. Such termination deposit will be refunded in equal amounts at the end of each full year of service. This annual refund will be the termination deposit divided by the number of years in the contract period.
