The following citizens provided public comments:

- Dan Caster, 5244 Blue Lilac Lane of Wake Forest, spoke about the new maps for Highway 1 and Star Road. [Capital Blvd and Frontage Road Issues]
- Michael Frazier, 2510 Countrywood Rd, spoke about the Capital Blvd upgrade affecting lands at Capital Blvd and South Main Street, specifically the proposed closure of Star Road.
- Maria Magana, resident of Wellington Park, appreciated the Board's
  assistance with the circumstances. She found a new lot to relocate and is
  awaiting on permits which is delaying the process to move.
- Ken Marsh, 105 Lance Lane of Youngsville, member of St. John's Episcopal Church in Wake Forest stated his gratitude to the Board of Commissioners, Triangle Family Services, community churches and the broader community supportive of the Wellington Park residents.
- Ronnie Jackson, 127 Deerfield Crossing Drive of Wellington Park, thanked the Town of Wake Forest elected official and churches for their support. He found a law in several states that prohibits the sale of the mobile home park before offering the existing residents the right of refusal.
- Kenille Baumgardner, 121 W Vernon Avenue, expressed concerns about Wellington Park.
- Bill Moran, 124 Deerfield Crossing Drive of Wellington Park, questioned if the funds will continue after January 15th as he is living in a hotel until his home is built.
- Sofia Miro, 105 Deerfield Crossing Drive of Wellington Park, stated her home is also her mother's home. She has been searching since March of 2021 for a home and found a lot and will be able to move the end of January 2022.
- Joy Shillingsburg, 1329 Colonial Club Road, stated she is the Director of the Wake Forest Community Meal Program and cares deeply for the neighbors of Wellington Park. She spoke in favor of an affordable housing policy.
- Jonne Allyson Boone, 523 Wayne Ave, Executive Director of Threads of Grace which is a local non-profit assisting low-income families. She spoke for a family in Wellington Park for whom the non-profit purchased a mobile home, and this was meant to be a permanent home.

**WHEREAS**, a Joint Public Hearing was held on December 7, 2021 by the Wake Forest Board of Commissioners and Planning Board; and

**WHEREAS**, the Planning Board recommended denial of the rezoning 6-0 as shown in Exhibit 1; and

WHEREAS, after reviewing all the information presented at the Public Hearing and the Wake Forest Community Plan and Unified Development Ordinance, the Wake Forest Board of Commissioners find the zoning map amendment request inconsistent with the Community Plan and adopted a written inconsistency statement, which is on file with the Wake Forest Planning Department and as shown in Exhibit 2;

**NOW, THEREFORE, BE IT RESOLVED** that the Wake Forest Board of Commissioners deny the Zoning Map Amendment request RZ-19-10 that is inconsistent the Community Plan and not in the public's interest.

## 7.B. Wellington Park Discussion

Mayor Jones read into the record the email Planning Director Courtney Tanner provided to the Board of Commissioners:

They developed a list of residents who are eligible for the money. The money was given to Triangle Family Services - \$375,000. Once all the invoices have been provided showing expended relocation funds, the Town will reduce the recreation facility fee due to one-third of the funds used. All of the funds have been given to Triangle Family Services. The developer was required to collaborate with the Wellington Park residents and working with the residents a potential list of eligible recipients was created. That was given to Triangle Family Services. Triangle Family Services visited the site multiple times to confirm names. Triangle Family Services is fully staff and meeting with residents. They have assisted residents with housing searches and application procedures, exploring alternative parks, assisting residents with arrangements for dumpsters and pods and storage units. And identifying and contacting and negotiating with mover-toter options. The process for reimbursement is the eligible resident submits expense to Triangle Family Services. If the reimbursement is missing information, Triangle Family Services works with the resident. If the expense is ineligible, then Triangle Family Services the client is told why it is ineligible. The amount paid out as of December 14, 2021, is \$126,279.06. As of December 14, 2021: ten residents have moved, six have new lots secured and toter arrangements are in progress, eleven have new housing secured and the move is planned, and six are still seeking alternative housing.

Commissioner Wall-Lennon stated she requested to have a staff member present so that she may ask questions. She asked if the funds expire.

Mayor Jones stated Triangle Family Services has the funds and the resident(s) will need to provide a receipt.

Strategic Performance Manager Lisa Hayes provided an overview of the Wireless Research Center Digital Hub Update and ARPA [American Rescue Plan Act] funding. She added Chief Financial Officer Aileen Staples is co-presenting with her. She added Jerry Hayes is in the audience if there are questions.

Chief Financial Officer Aileen Staples stated the County funding piece was removed from the agreement, the Town's audit firm is assisting with the compliance of the ARPA funds, and the payment schedule was updated.

Strategic Performance Manager Lisa Hayes provided an overview of the DuBois improvements.

Commissioner Wall-Lennon stated she supports the project at DuBois. She stated now the agreement is being revised. She questioned the off set for funding.

Jerry Hayes stated the change is the County's schedule until February 28, 2022, to discuss.

Commissioner Simpers questioned what if the money does not come to fruition.

Jerry Hayes stated the schedule is not contingent on County funds and they are looking at outside sources for funding. The County is not out of the question and has received 213 submissions.

Commissioner Wall-Lennon stated this was an unsolicited proposal. She stated there are other organizations who may benefit from the ARPA funding. She would like to know the process for other entities that may ask for funding.

Strategic Performance Manager Lisa Hayes stated this will be an item for discussion at the upcoming Board retreat.

Commissioner Wall-Lennon stated she would support the request and raised concerns on the principal of the matter.

#### RESOLUTION 2021-157

Authorization to Fund the Wireless Research Center Digital Workforce Hub

WHEREAS, the Town of Wake Forest is dedicated to improvement of the digital divide and digital inequality; committed to workforce training in the community; and supports creating an environment of collaboration and cooperation to continue to build a strong, productive local economy; and

WHEREAS, the Wireless Research Center's Digital Workforce Hub seeks to address the digital divide and digital inequality in Wake Forest and the surrounding areas; and

WHEREAS, the Wireless Research Center's Digital Workforce Hub training will create a pool of skilled employees and build a more productive local economy.

WHEREAS, the Board of Commissioners for the Town of Wake Forest authorized a grant via Resolution on August 17th, 2021 in an amount not to exceed \$1,200,000 to the Wireless Research Center for the Digital Workforce Hub at DuBois campus, substantially in accordance with the terms and conditions set out in the attached Community Development Grant Agreement (The DuBois Campus Digital Workforce Hub) ("Contract").

WHEREAS, Town of Wake Forest Resolution 2021-107 was not ratified due to contract modification requests; and

WHEREAS, Wireless Research Center of North Carolina is requesting contract modifications to said contract;

NOW, THEREFORE, BE IT RESOLVED THAT the Board of Commissioners for the Town of Wake Forest hereby rescinds Resolution 2021-107 and authorizes Resolution 2021-x to approve a grant in an amount not to exceed \$1,200,000 to the Wireless Research Center for the Digital Workforce Hub at DuBois campus, substantially in accordance with the terms and conditions set out in the attached Community Development Grant Agreement (The DuBois Campus Digital Workforce Hub) ("Contract").

BE IT FURTHER RESOLVED, that the Town of Wake Forest's Attorney, Town Manager and Chief Financial Officer are hereby authorized to revise and edit the Contract in such a manner as is reasonably necessary to accomplish the goals and objectives of granting funds to WRC to create a Digital Workforce Hub in Wake Forest; (ii) approve the final version of the Contract provided the final Contract is substantially in accordance with the version attached hereto; and (iii) the Town Manager is hereby authorized to execute the final Contract on behalf of the Town of Wake Forest, without further action or approval of the Board of Commissioners.
