5. Commissioner Reports

Mayor Pro Tem Simpers and Commissioner Sary stated no report.

Commissioner Wright stated he provided a webinar last Thursday on adult daycare. As a result of the webinar, attained 18 subscribers to the Senior Center. He attended the Technology meeting last week with discussion on the STEM event next year.

Commissioner Dyer stated he is the liaison to the Historical Advisory Council, and he attended the two-day virtual conference hosted by the North Carolina Preservation Council. At the last meeting he mentioned John Mills who passed away last month, and he officiated his funeral. He stated November 11 is Veterans Day and there will be an event at the memorial and the public is invited to attend.

Commissioner Wall-Lennon stated the Urban Forestry Board met last Tuesday and discussed obtaining American Chestnut Trees for Joyner Park. She added Luke DeVores, Urban Forestry Coordinator, gave two talks on Fall Foliage Tours on Wednesday and he will host two more on Saturday.

Mayor Jones stated Officer First Class Rob Wilkinson was named the 2020 Crisis Intervention Team (CIT) Officer of the Year for the Town of Wake Forest Police Department. He was also selected as the 2020 Wake County CIT Co-Officer of the Year. She stated the Town hosted the S-Line Transit Oriented Development Planning Study Advisory Committee in the plaza and NCDOT and Rail Division are the leads for the study. She attended the CAMPO Retreat in which the focus was the strategic plan. TJCOG hosted a virtual summit on strategic planning. She attended the RTA Regional Alliance Meeting today and added this is its 20th year. She stated the focus of the meeting is the Triangle communities working together. She attended the ribbon cutting at Brookfields Indoor Golf and Lounge at The Factory. She attended the Infinite 30 Weight Loss and Wellness 5th anniversary celebration. This business was begun in Wake Forest and is now franchised in eight states. She attended the BW Wells Association meeting. BW Wells is near the Wake Forest Community and a state park site. The Northeast Make a Difference Day was a good event. The Wake County Commissioners appointed her to another term with the Go Triangle Board of Trustees. She attended the Garden Club event.

Town Manager Kip Padgett stated the Northeast Area Plan is available on the Town's website for review.

Town Manager Kip Padgett recognized Town Planning Director Courtney Tanner and wished her a happy birthday.
