3. Presentations

3.A. Special Presentation

NC Insurance Commissioner Mike Causey announced that the Wake Forest Fire Department earned a Class 1 Public Protection Classification rating by the Insurance Services Office. Mr. Causey stated the Class I represents the highest possible fire protection service. Mr. Causey stated the Wake Forest Fire Department is one of eighteen communities in North Carolina that has earned a Class 1 designation.

Fire Chief Ron Early accepted the Class 1 designation on behalf of the Wake Forest Fire Department.

3.B. Proclamation recognizing November 26, 2021, as "Plaid Friday" and November 27, 2021, as "Small Business Saturday"

Mayor Jones read the proclamation into the record:

Proclaiming Friday, November 26, 2021, as Plaid Friday And Saturday, November 27, 2021, as Small Business Saturday

WHEREAS, purchasing holiday gifts and shopping year-round with locally owned and independent businesses supports the economic health and resilience of the community; and WHEREAS, shopping locally supports our neighbors, friends, and family members employed by local businesses; and

WHEREAS, when we support small business, jobs are created, and local communities preserve their unique culture; and

WHEREAS, just like the individual, the individual threads are weak on their own but are strong together, so is our community. Together supporting one another while celebrating our uniqueness we are interwoven and strong; and

WHEREAS, Plaid Friday is a fun and enjoyable alternative to the big box store "Black Friday" consumer frenzy where everyone is encouraged to wear plaid and shop local and independent; and

WHEREAS, Small Business Saturday is a nationwide campaign to cultivate business for small merchants on the Saturday after Thanksgiving; and

WHEREAS, Plaid Friday and Small Business Saturday celebrate and support small businesses and all they do for Wake Forest.

WHEREAS, we encourage citizens to consider shopping our small merchants on Plaid Friday and Small Business Saturday as a way to boost the local economy and strengthen our small business community.

WHEREAS, the Town of Wake Forest, North Carolina supports and joins in this national effort to help America's small businesses do what they do best – grow their business, create jobs, and ensure that our communities remain as vibrant tomorrow as they are today.

NOW THEREFORE, I, Vivian Jones, Mayor of the Town of Wake Forest, in the State of North Carolina, do hereby proclaim

November 26, 2021, as Plaid Friday and November 27, 2021, as Small Business Saturday and encourage our residents to recognize and support small businesses within our community by shopping these establishments on the Friday and Saturday following Thanksgiving.

Mayor Jones presented the proclamation to Downtown Development Manager Jennifer Herbert and Downtown Business Alliance Chair Marissa Shattuck.

Marissa thanked the Mayor, Board of Commissioners, and the community for supporting small local businesses.

4. Public hearings / Public Comment

4.A. Consideration of and Public Hearing on Legislative Case RZ-21-07 to Clarify and Reaffirm the Town of Wake Forest Zoning and Overlay District Maps

Rick Ostergard of 8032 Hawkshead Rd., Wake Forest, NC asked if there's any property in the Town that has a questionable zoning on it that the affirmation of this zoning map is going to legalize. Mayor Jones replied, this is a reaffirmation and there's nothing being done tonight. He spoke about zoning changes and is unsure how the process works. Mr. Ostergard said there was a map that changed zoning within a month without any noticeable zoning action that the zoning was changed. Commissioner Sary stated it was a result of when the UDO was adopted.

Wanda Mukherjee of 1208 Chilmark Ave., Wake Forest, NC spoke on behalf of Riverstone HOA Governmental Affairs Committee and the concerned citizens for the Preservation of Wake Forest Open Space. She asked the board if this is correcting something that was not done properly in the past and assumes that it is not because of Commissioner Sary's response that it was a result of when the UDO got adopted. Ms. Mukherjee addressed community engagement involving the citizens of Wake Forest. She said in order for the public to understand they need to know the underpinning of things such as "what prompted this?" and "why are we taking this action now?" "why are we doing this before the newly elected candidates are seated?" She expressed concern about some of the watershed designation areas for the neighborhoods on the northwest side of Capital Blvd. are missing from the current zoning in the UDO. Ms. Mukherjee asked that the public hearing be continued until January when the newly elected candidates are seated.

Margaret Watkins of 407 Belmellen Ct., Wake Forest, NC said, if approving the map tonight there would be a bias on an upcoming quasi-judicial hearing. She said according to the board those decisions will have to be made on that hearing as an impartial decision maker.

Commissioner Wall-Lennon said there was conversation about the northeast being an overlay district and asked when they'd entertain the thought or consideration for the northeast. Planning Director Tanner stated the next round would be to go back out to

the community and reaffirm those guidelines with the community and then have an overlay if supported by the board.

Commissioner Sary asked if the area on the northwest side of Capital Blvd. is within the Falls Lake Watershed Management Area. Planning Director Tanner replied, not all, but most of it is. She said there's both critical and non-critical which are identified by the state. Commissioner Sary asked if it's currently an overlay district. Planning Director Tanner replied, correct and they have the overlay district that ties to additional standards identified in the UDO. Commissioner Sary said that will continue and nothing will change with the action tonight. Planning Director Tanner replied, correct.

Commissioner Wall-Lennon asked if someone would address the issues brought before the board. Planning Director Tanner explained this is a legislative process they're going through now and any quasi-judicial process regardless of the case has nothing to do with it and are distinctly different. She said this is reaffirming the zoning map that is effective as the date of today.
