PROCLAMATION

PROCLAMING APPRECIATION AND GRATITUDE FOR THE CONTRIBUTIONS TO FUNDAMENTAL PRINCIPLES OF ONENESS AND NONVIOLENCE BY THE SUPREME PONTIFF OF HIDUISM NITHYANANDA PARAMASHIVAM IN NORTH CAROLINA

WHEREAS, The Sovereign State of SHRIKAILASA is a peaceful, sovereign, service-oriented Hindu indigenous Nation and the First Nation of Hindus, rooted in the fundamental principle of Oneness and non-violence - the idea that all beings can live in peace and harmony, and that all human beings are equal and divine, and can reach their highest potential irrespective of their color, nationality, religion, gender or race; and

Margaret Watkins asked the Board of Commissioners to consider extending the hours of the Wake Forest Loop Bus during Friday Night on White.

Mayor Jones asked if anyone else had any public comments. No one came forward to speak. Mayor Jones closed the public comment.

6. Legislative Items

6.A. Consideration of an Ordinance Amending the Code of Ordinances Chapter 14, Article III, Section 14-66 thru 14-75 - Noise

Strategic Performance Manager Lisa Hayes presented the proposed updates to the noise ordinance and provided some background on the noise ordinance. She provided a summary of the feedback received from an online survey:

- Quiet Hours
- Permit Notification Ms. Hayes stated the citizens preferred method would be through email.
- Permit Review Time Ms. Hayes stated the best responses were between 1-5 days or 1-2 weeks. Staff would propose a 7-business day turnaround.
- Changes in Permitting- Earlier end time, available option to be louder than previously.
- Overall Comments

Ms. Hayes stated the comments would be made available online.

There were 325 comments received from the online survey. Ms. Hayes said most responses identified quiet hours from 9:00 p.m. to 8:00 a.m. with the exception of Friday and Saturday nights being 10:00 p.m.

Ms. Hayes identified the following top five issues received from the online survey:

- 1. Loud Mufflers & Vehicles
- 2. Fireworks
- 3. Residential Parties & Music
- 4. Traffic
- 5. Lawn & Landscaping

Ms. Hayes provided an overview of standardized hours and decibel readings. She provided an overview of the permitting process, clarified citation rules and the update on enforcement and penalty process.

Commissioner Sary asked if the Police would enforce the noise ordinance. Ms. Hayes stated the Police will enforce on the weekends and Planning Department Staff will work on enforcing the noise ordinance during the week.

Commissioner Wright asked how loud amplified music is during an event downtown. Ms. Hayes replied, between 60-65 decibels but they're proposing it be moved to 75-decibels.

Mayor Jones said it appears someone can request a permit for 365 days. Ms. Hayes replied yes, if you want to exceed the 75-decibels you could request a permit for 365 days. The Planning Board will investigate further to see if it's reasonable and responsible. If staff receives a lot of complaints staff would revoke the permit.

Mayor Jones asked if a lot of businesses had inquired about playing their music louder. Ms. Hayes replied, no. Mayor Jones said she doesn't understand why they want to raise the decibel level. Ms. Hayes explained, businesses were going above the current 60-65 decibels limit and were required to apply for a permit but with the proposed change to 75-decibels businesses would fall within the decibel limit and would not have to apply for a permit.

Commissioner Wright asked how it would affect Friday Night on White (FNOW). Ms. Hayes said it would not. Commissioner Wright asked if town events were exempt. Assistant Town Manager Allison Snyder clarified that town events are not exempt. Commissioner Wright asked if they're going to offer an exception. Ms. Hayes said she's not sure they've measured the decibels at FNOW but would do so. Commissioner Wright wants to make sure they're not impacting FNOW or any other similar live events.

Mayor Jones commented this may work well for downtown and commercial businesses, but this is a town wide ordinance. She asked what would happen if my neighbor were having a party. Ms. Hayes stated if they were to exceed the 75-decibel limit, they'd be issued a citation if exceeding the decibel limit. Mayor Jones expressed concern with a 75-decibel limit in a residential area.

Commissioner Sliwinski asked if they could differentiate between a commercial and residential ordinance. Assistant Town Manager Allison Snyder did look at outlining by zoning and outlining by use but because of the intermix of uses it didn't end out being a fair assessment, so staff decided going town wide.

Mayor Jones asked what can be done about barking dogs. Ms. Snyder said barking dogs are currently handled by Wake County Animal Control, but animal control is limited on what they can do about a barking dog. She said it would have to be based on the dog's health and physical welfare for animal control to take action.

Commissioner Sary asked if commercial and residential can be separated. He said more needs to be done on the residential side. Commissioner Sary would like staff to prod a bit more from the residential side. He would also like to have a 6-month grace period to see how it's working.

Commissioner Sliwinski asked if it's possible that 75-decibels at one end of town can come off different on the other side of town. Ms. Hayes replied, yes.

Commissioner Shackleford stated he'd like a second reading.

Ms. Hayes stated staff will perform further research and bring it before the Board at a later date.
