Elizabeth Mitchell, 251 Capellan St., Wake Forest, NC stated traffic was her concern.

Consideration of LEGISLATIVE CASE RZ-22-01, Wake Union, a rezoning filed by Kimley-Horn to rezone 71.46± acres located at 0 Wake Union Church Road, 0 and 12415 Capital Boulevard, and 0 Kearney Road, being Wake County Tax PINs 1831644698, 1831751080, 1831646036, and 1831537516, from Conditional Use Highway Business (CU HB) to Residential Mixed- Use Conditional District (RMX-CD) and Neighborhood Mixed-Use Conditional District (NMX-CD).

Commissioner Dyer inquired about a roundabout at Kearney Rd. Senior Planner Patrick Reidy said one of the conditions is the applicant would further investigate a roundabout at the intersection of Wake Union Church Rd. and Kearney Rd. The funding and construction would be negotiated through a Developers Agreement.

Mayor Jones asked what was the original condition #14 regarding the height of buildings. Mr. Reidy stated the original condition #14 spoke to the two buildings directly across from Prestwicke Subdivision. It was limiting those two buildings not to exceed four-stories.

Commissioner Sary asked if the developer would conduct a study on a roundabout and come back to the Board with the results. Mr. Reidy replied yes, as a separate reimbursement development agreement.

Mayor Jones asked why they're removing the walking trails and community garden from the open space. Mr. Reidy stated the Planning Board felt the walking trails and community garden were already being provided and they'd have more recreation opportunities by removing those two.

Commissioner Sliwinski asked about the increase in traffic with the new improvements on Capital Boulevard; specifically, where the new intersection would be installed. Mr. Reidy said he did not have the numbers available, but the traffic consultant is in attendance and may be able to speak more on that.

Commissioner Dyer asked when a decision is going to be made on what they're going to do at the traffic circle. Mr. Reidy said that'll be part of the construction drawings.

Commissioner Sary asked the timeline of the project. Mr. Reidy believes sooner rather than later. His understanding is it could move quickly. Commissioner Sary suggested a timeframe put on the project versus just leaving it out there.

Town Manager Padgett stated this is not a quasi-judicial hearing and if the Board would like to talk with the engineer, even though the public hearing is closed, they can come up and answer questions.

Commissioner Sary would like to hear the timeframe from the developer. Trace McCreary with Varden Capital Properties (VCP) said they're supportive of cooperating with the town and if the Board would like to enter into an agreement, they would be supportive of it.

Traffic Engineer Travis Fluitt with Kimley Horn and Associates spoke about the different phases of traffic flow. Mr. Fluitt said the main crossover intersection would operate comparably to the way the intersection does today in terms of level of service. Mr. Fluitt stated all movements in the intersection will be signalized.

Commissioner Sliwinski asked what happens if NCDOT doesn't approve it. Mr. Reidy said he's pretty certain it's locked in. Mr. Fluitt said NCDOT has approved the configuration as part of the Traffic Impact Analysis (TIA).

Commissioner Sary said anytime you have thirty plus conditions on an application it shows the developers, homeowners, and the town are working together. He likes the fact there is a good portion of the site that is non-residential. He said there may be some traffic issues to deal with but thinks that's the case everywhere in town. Commissioner Sary believes it's consistent with the Community Plan and is in support of the project.

Commissioner Sary met with Lee Worsley, Executive Director with Triangle J Council of Government (TJCOG), attended the ribbon cutting at Truist Bank on S. Main Street, participating in the DFI Interviews this week, attending the Public Arts Commission meeting next week.

Commissioner Shackleford had no updates.

Commissioner Sliwinski said Art in the Park is on August 27, 2022, co-hosting the Mental Health Care webinar with Commissioner Wright in cooperation with Wake Med on August 11, 2022, not able to attend the Parks, Recreation & Cultural Resources (PRCR) meeting next week and welcomed the newly appointed members of the PRCR.

Commissioner Dyer attended a 105th birthday celebration, attended the ribbon cutting at Truist Bank, Memorial Flag-Raising Ceremony on Monday, August 1, 2022.

Commissioner Sliwinski asked how many acres the site is. Ms. Tanner said she'll have to go back and look and will send the
