WHEREAS, Beverly "Bev" Whisnant served most recently on the Historic Preservation Commission of the Town of Wake Forest from 2017 to 2022 and previously from 2002 to 2008; and

WHEREAS, Beverly "Bev" Whisnant advocated for the preservation of the Wake Forest's History, Historic Districts and Properties; and

WHEREAS, Beverly "Bev" Whisnant put forth substantial effort toward improving the quality of life for the citizens of the Town of Wake Forest and has been previously recognized by the Town of Wake Forest as its Citizen of the Year and with the Distinguished Service Award from the Wake Forest College Birthplace Society; and

WHEREAS, Beverly "Bev" Whisnant served unselfishly in her capacity for the good of the Town of Wake Forest, as a founding and current member of the Wake Forest Historical Association, member of the Ailey Young House Steering Committee, the Community Christmas Dinner Committee, Kiwanis, and General James Moore Chapter of the Daughters of the American Revolution; and volunteer for the Wake Forest Historical Museum; and WHEREAS, the Wake Forest Historic Preservation Commission, at their January 12, 2022 meeting, voted unanimously to recommend approval of this resolution to the Board of Commissioners; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Town of Wake Forest, North Carolina, that Beverly "Bev" Whisnant is hereby officially commended by this Board on behalf of the citizens of Wake Forest for valuable service rendered to the Town of Wake Forest.

BE IT FURTHER RESOLVED that this resolution be made a part of the permanent records of the Town of Wake Forest and that a copy of this resolution be presented to Beverly "Bev" Whisnant.

3.B. Presentation of Proclamation Proclaiming Mayor's Monarch Pledge Month

MAYORS' MONARCH PLEDGE MONTH

WHEREAS, the monarch butterfly is an iconic North American species whose multigenerational migration and metamorphosis from caterpillar to butterfly has captured the imagination of millions of Americans; and

WHEREAS, 20 years ago, more than one billion Eastern monarch butterflies migrated to Mexico, but populations of this iconic species have declined by 90% in the last two decades; and WHEREAS, cities, towns, and counties have a central role in raising awareness in the effort to help save the monarch butterfly and the Town of Wake Forest has played a leadership role in the effort to protect the monarch butterfly by planting a milkweed garden at E. Carroll Joyner Park and at the Northern Wake Senior Center; and

WHEREAS, every resident of Wake Forest can make a difference for the monarch by planting native milkweed and nectar plants to provide habitat for the monarch and pollinators in locations where people live, work and play; and

WHEREAS, on behalf of the residents of Wake Forest, I have signed the National Wildlife Federation's Mayors' Monarch Pledge to bring awareness to this issue; and

NOW, THEREFORE, I, Vivian A. Jones, Mayor of the Town of Wake Forest, North Carolina do hereby proclaim April, 2022, as Mayors' Monarch Pledge Month in the Town of Wake Forest and encourage all residents to preserve and strengthen the monarch butterfly population.

Jennifer Amyx at 9908 Calvados Drive, Wake Forest, NC stated she is a member of the Local Chapter of the North Carolina Wildlife Federation. She thanked the Board for the Monarch Pledge and thinks it's important. Ms. Amyx noted some of the details in the proclamation suggests more leadership of the town then is actually being made. The milkweed at Joyner Park is all naturally occurring milkweed and was not planted as a garden by the town. Ms. Amyx stated the garden at the senior center also has milkweed that was planted by members of the Neuse River Hawks Local Wildlife Federation. Ms.

Amyx wanted to clarify those things and thanked the Board for elevating the mission of the monarch butterflies. Mayor Jones apologized and thought the Parks & Recreation staff had planted some of the milkweed at Joyner Park. Mayor Jones will check with Town staff to confirm.

7. Planning Items

7.A. Consideration of LEGISTLATIVE ITEM TA-22-01 Text Amendment to the Unified Development Ordinance

Mayor Jones stated the Planning Board voted (6-1) to find the request consistent with the Comprehensive Plan and recommended approval with the condition to strike the following language in the Unified Development Ordinance (UDO) Section 9.5.5 (A): (e.g., structure could be wrapped by retail, office or some other active use along the primary façade).

Commissioner Sary asked the reasoning behind the text amendment. Planner II Dylan Bruchhaus stated the original language is written with the intent of only having the first story of the parking structure wrapped and as staff expanded it to capture multiple stories the Planning Board suggested removing the original language.

Senior Planner Kari Grace provided an overview of the professional services contract of the comprehensive UDO and MSSD update.

Commissioner Dyer asked how they came up with an amount of a \$337,905 budget. Ms. Grace responded it's a combination of the work associated with the UDO update as

well as MSSD updates. She said this was proposed by the consultant, not necessarily staff, as far as itemizing out each item.

Commissioner Sary asked what role will Tool Design be playing in the process. Ms. Grace stated Tool Design would serve as the technical consultant on the MSSD updates.

Commissioner Sary asked what the make of a UDO Advisory Committee would be. Ms. Grace said they haven't reached out to make any invitations as of yet because the project hasn't been approved to proceed. Ms. Grace said they do envision the committee including stakeholders, business owners, the development community, and residents.

RESOLUTION APPROVING AMENDMENT TO PURCHASING AND WAREHOUSE POLICY

TOWN OF WAKE FOREST, NORTH CAROLINA

WHEREAS the Board of Commissioners approved a purchasing policy in October 2007 and updated in August 2019. This policy outlines the responsibilities and procedures governing the purchases of goods, equipment and services for the Town of Wake Forest.

WHEREAS the policies and procedures provided ensure the fair and equitable treatment for all parties involved in public purchasing is demonstrated while following all applicable statutory requirements; and

WHEREAS, North Carolina General Statute 143-129 states the following: For purchases of apparatus, supplies, materials, or equipment, the governing body of any political subdivision of the State may, subject to any restriction as to dollar amount, or other conditions that the governing body elects to impose, delegate to the manager, school superintendent, chief purchasing official, or other employee the authority to award contracts, reject bids, or readvertise to receive bids on behalf of the unit. Any person to whom authority is delegated under this subsection shall comply with the requirements of this Article that would otherwise apply to the governing body.

WHEREAS the Board of Commissioners delegates authority to the Town Manager and/or his designee (Purchasing Manager or Chief Financial Officer) to authorize any purchase of apparatus, supplies, materials or equipment up to \$1,000,000.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Town of Wake Forest amends the Purchasing and Warehouse Policy as presented.

WHEREAS, the Board of Commissioners participated in a retreat on January 21, 2022, with a main purpose of reviewing and finalizing the draft Strategic Plan Update 2022; and WHEREAS, during the retreat, the draft Strategic Plan Update 2022 was analyzed for continued relevance and priority recommendations were made for each goal; and WHEREAS, the Town Manager will work with staff to develop tasks, measures, and descriptions of what will be done to complete the objectives outlined in the Strategic Plan Update 2022; and

WHEREAS, the Strategic Plan Update 2022 will be effective at the beginning of the new fiscal year, July 1, 2022: and

NOW, THEREFORE, BE IT RESOLVED by the governing body of the Town of Wake Forest hereby approves the Strategic Plan Update 2022 as set forth in the attached Exhibit #1 - Strategic Plan Update –2022.

RESOLUTION OF THE BOARD OF COMMISSIONERS REGARDING ACQUISITION OF A FEE SIMPLE INTEREST IN CERTAIN PROPERTY AS PART OF THE EXTENSION OF THE SMITH CREEK GREENWAY PROJECT

WHEREAS, the Town of Wake Forest ("Town") received a grant from the North Carolina Clean Water Management Trust Fund, a division of the North Carolina Department of Natural and Cultural Resources ("CWMTF") for the acquisition of fee interests in certain subdivided parcels situated north of Burlington Mills Road along the Smith Creek corridor over which the

Town intends to complete certain greenway improvements to extend the Smith Creek Greenway trail and amenity system ("Project");

WHEREAS, the Board of Commissioners of the Town ("Board") hereby determines that it is necessary and in the public interest to acquire fee interests in certain subdivided parcels situated north of Burlington Mills Road along the Smith Creek corridor for the following public purpose: To protect the safety, comfort and public wellbeing for Town citizens and to provide the public certain riparian greenway amenities and improvements for environmental, educational and recreational uses;

WHEREAS, the parent tract to be subdivided and included in the Project is currently owned by Jeffrey W. Newhouse and Lisa A. Hayes f/k/a Lisa A. Newhouse, such parent tract located at 2004 Old Crawford Road, Wake Forest, NC 27587 and comprised of approximately 4.42 acres (in aggregate) and identified by the Wake County Revenue Department as Parcel Identification Number(s) #1749156658 (the "Newhouse Tract"), of which 0.46 acres is to be created via subdivision and included in the Project for the construction of future greenway extension and improvements ("S-5 Parcel");

WHEREAS, the Town attempted to acquire the S-5 Parcel by way of direct negotiations with the owners of the Newhouse Tract pursuant to the terms and conditions of the Grant, but was unable to do so, and therefore, the acquisition of said S-5 Parcel is no longer subject to the CWMTF grant, but is nonetheless still vital to the Project;

WHEREAS, the Board, having found that the public purpose described herein together with the furtherance of the Project necessitates the acquisition of the S-5 Parcel as more particularly described on <u>Exhibit A</u> and depicted on <u>Exhibit B</u>, each attached hereto and incorporated herein by reference, directed the Town Attorney at a duly held Closed Session of the Meeting of the Board of Commissioners dated March 15, 2022 (the "Closed Session Directive"), to file a condemnation action to acquire the S-5 Parcel; and

NOW, THEREFORE, BE IT RESOLVED by the Board that the Town hereby ratifies the Closed Session Directive which authorized the fee acquisition of the S-5 Parcel, by eminent domain, or other agreement between the parties, for the continued implementation and furtherance of the Project and public purpose described herein and such other lawful purposes to which the Town may devote the S-5 Parcel.

BE IT FURTHER RESOLVED that all prior actions of the Town Attorney and staff or the Town on behalf of the Town pursuant to the Closed Session Directive are hereby ratified and confirmed, and the Town Attorney and staff of the Town be and are hereby authorized and directed to proceed with such additional notices, filings and other necessary proceedings in the Superior Court of Wake County, North Carolina, to effectuate the acquisition of the S-5 Parcel authorized by the General Statutes of North Carolina, special act or the Charter of the Town,

said Town Attorney being hereby authorized on behalf of the Town to give or receive such notice or notices as may be by law required.
