4.A. Public Hearing on LEGISLATIVE CASE RZ-23-02, Stadium Drive Mixed Use, a rezoning filed by Williams Mullen to rezone 19.30 acres located at 0 Stadium Dr, being Wake County Tax PIN 1831957846 from Rural Holding District (RD), Richland Creek Watershed Management Area District (RC-WMA), and Special Highway Overlay (SH1-O) to Neighborhood Mixed-Use Conditional District (NMX-CD), Richland Creek Watershed Management Area District (RC-WMA), and Special Highway Overlay (SH1-O).

The following citizen provided public comment:

Margaret Watkins, who resides at 407 Belmellen Ct. in Wake Forest, NC 27587, expressed her satisfaction with the developer's efforts in collaborating with the HOA and neighboring property owners. However, she emphasized that for her to fully support this development, she would like to see an improved intersection at the shopping center.

Applicant Tom Johnson with Williams Mullen provided an overview of the project, discussing the site plan, future road alignment, treatment of additional stormwater, additional environmental conservations, retail incubator space, and displaying renderings. Mr. Mullens also provided details on additional and modified conditions.

Mayor Jones asked if anyone else would like to speak. No one else came forward to speak.

Mayor Jones declared the public hearing closed.

4.B. Public Hearing on Stormwater Utility Fee

Assistant Stormwater Engineer Nick Nolte provided an overview of the Stormwater Utility Fee Advisory Group recommendations. He stated with the changes to the Code of Ordinances Town Staff has decided to consolidate all their stormwater regulations into Chapter 14 of the Code of Ordinances. This chapter includes a civil penalty section that requires two votes and two readings.

Mayor Jones inquired whether townhomes are considered residential or commercial. Mr. Nolte stated that non-residential would include multi-family with five or more residential units. Therefore, if it falls under that category, they will consider it multi-family.

The following citizen provided public comment:

calculation method used for driveways and walkways. She also expressed her
concern about the Board voting on this item tonight. Ms. Watkins asked about
the availability of credits for those who are financially struggling and believes it
needs to be addressed before the Board makes a decision.

Mayor Jones asked if anyone else would like to speak. No one else came forward to speak.

Mayor Jones declared the public hearing closed.

4.C. Public Hearing on Community Plan Amendment related to the Wake Forest/Raleigh Utility Merger Agreement (CPA-23-03)

Planning Director Courtney Tanner stated the purpose of this amendment is to provide staff, the Planning Board, and the elected body guidance should anyone bring forward an annexation request as well as a rezoning request to receive water and/or sewer. She said staff are currently drafting UDO standards for conservation subdivisions. This is an interim measure to help protect and ensure compatibility until those are adopted.

Commissioner Wright asked if this is considered a rezoning. Ms. Tanner replied, no.

Commissioner Wright asked if there would ever be a lower zone than General Residential as far as density. Ms. Tanner explained, that in the new UDO, there are no density provisions. She said the goal is to focus on design, not density. It's too early to tell what all the zoning districts will be.

Commissioner Wright asked what would happen if they didn't do this. Ms. Tanner replied, worst case scenario is you'd end up with incompatible uses in this area.

Commissioner Wright asked what the steps would look like if they asked for a new zone in the UDO. Ms. Tanner replied that it could potentially cost more time and money, according to state statute their UDO needs to be developed by using the Community Plan as a guide, and there could potentially be inconsistencies.

Commissioner Wright asked if the current landowners Andy Ammons and Ms. Willis have any plans to do any type of building out there. Ms. Tanner stated she has spoken to both property owners and one property owner said she made a promise to her grandmother that the property would remain as is and she intends on keeping that promise. Ms. Tanner said she made it clear that if something were to happen and the land was given to her children, she couldn't guarantee what would occur. Ms. Tanner said Mr. Ammons develops land and that is what he does for a living so she can't guarantee he doesn't have some application in the future.

Commissioner Sliwinski asked if the amendment would change, remove, or amend a watershed overlay district. Ms. Tanner replied there are state and local requirements, and Wake Forest and Wake County have requirements. Those remain in place and don't change as a result of this.

Commissioner Wright asked if the main purpose besides guidance is to be able to help better conservation of the land. Ms. Tanner said if it were to be developed it should be developed under the conservation provisions that are being drafted in the UDO.

Commissioner Sliwinski asked about the potential of a traffic light at the intersection. Mr. Reidy stated part of the issue is the realignment that must happen for both the current development under consideration and the shopping center. Mr. Reidy also said the Traffic Impact Analysis (TIA) didn't warrant it and NCDOT didn't make a request for the signal. Commissioner Sliwinski asked about a crosswalk. Mr. Reidy replied they have other locations and sometimes NCDOT approves it and may add additional signage, striping, pavement markings, or flashing beacons. He said that has a pretty good chance of being approved in some manner. Commissioner Sliwinski said he understands the developer worked with the neighbors and that's fantastic but he's having trouble getting past a potentially dangerous intersection. Commissioner Wright agreed but said when he looks at the development itself, he loves mixed-use. Unfortunately, with the intersection and not knowing fully what they're doing on Capital Blvd. he's not comfortable doing anything with that right now.

Commissioner Wright asked, based on the feedback received at the public hearing by Mr. Olsen would it be possible to make those three changes and what would the process involve in doing so. Ms. Tanner explained the procedures and the limitations in terms of what could be modified.

Commissioner Wright recommended tabling the discussion until they can have further impact.

Commissioner Sliwinski expressed concern about tabling it and being left hanging out there without any protection.

Commissioner Sary expressed his concerns and believes it would be better protected if the Town were able to facilitate things that happen in the future. He doesn't think Wake County has their best interest in mind.

Commissioner Dyer withdrew his motion to second.

Commissioner Shackleford said at least there is one property owner who has no intention of coming before the Board asking for a rezoning request, which means to him that a large portion of that property would remain intact as a forest. Commissioner Shackleford would like to see the expansion of the description of the whole area.

Commissioner Sliwinski commented that this does not expand the ETJ nor the Town's jurisdiction, and at this point, they're not rezoning and are not putting a zoning classification on it; additionally, if someone wanted to build under R 80W zoning within the county they could still do that.

The motion died due to a lack of second.
