PROCLAMATION PROMOTING NORTH CAROLINA PUBLIC POWER DURING PUBLIC POWER WEEK, OCTOBER 2 – 8, 2022

WHEREAS, public power meets the electric needs of 40 million Americans, almost 15 percent of electricity consumers; and

WHEREAS, North Carolina's public power communities provide homes, businesses and local government agencies with safe and reliable electricity employing sound business practices designed to ensure the best possible service; and

WHEREAS, many of North Carolina's 70 public power cities and towns have been electric providers for more than 100 years and provide 1.2 million citizens with safe, reliable power; and WHEREAS, North Carolina's public power utilities are dependable institutions that provide excellent service and a commitment to community and they are valuable community assets that contribute to the well-being of the community and provide economic development opportunities; and,

WHEREAS, the National Association of Town Watch (NATW) is sponsoring a unique, nationwide crime, drug and violence prevention program on Monday, October 3, 2022 entitled "National Night Out"; and

WHEREAS, the 39th Annual "National Night Out" provides a unique opportunity for the Town of Wake Forest to join forces with thousands of other communities across the country in promoting cooperative, police-community crime prevention efforts; and

WHEREAS, the Neighborhood Watch Program plays a vital role in assisting the Wake Forest Police Department through joint crime, drug and violence prevention efforts in Wake Forest and is supporting "National Night Out 2022" locally; and

WHEREAS, it is essential that all citizens of the Town of Wake Forest be aware of the importance of crime prevention programs and impact that their participation can have on reducing crime, drugs and violence in Wake Forest; and

WHEREAS, police-community partnerships, neighborhood safety, awareness and cooperation are important themes in the National Night Out program;

NOW, THEREFORE, I, Vivian A. Jones, Mayor of Wake Forest, do hereby proclaim Monday, October 3, 2022 as "NATIONAL NIGHT OUT" in the Town of Wake Forest, North Carolina and call upon all citizens of Wake Forest to support any activities planned downtown to recognize the "39th Annual National Night Out" and to be mindful of things going on in our neighborhoods and community.

WHEREAS, Pediatric Autoimmune Neuropsychiatric Disorders Associated with Streptococcal Infections, better known as PANDAS, is said to be a rare condition but is actually rarely diagnosed; and

WHEREAS, PANDAS is a term used to describe a subset of children who have Obsessive Compulsive Disorder and/or tic disorders such as Tourette Syndrome and in whom symptoms worsen following strep infections such as Strep Throat and Scarlett Fever; and WHEREAS, children are often misdiagnosed and treatment is delayed. There are many treatments and options for treating this condition but, unfortunately, they are often very expensive and not covered by insurance;

NOW THEREFORE, I, Vivian A. Jones, Mayor of the Town of Wake Forest, do hereby proclaim October 2022 as

"PANDAS Month in the Town of Wake Forest" and urge all citizens to become aware of this debilitating condition for children and work to make it more readily recognized by the medical profession and the insurance providers.

4.A. Public Hearing on CPA-22-02, Draft Town of Wake Forest Housing Affordability Plan

Dora Pearce at 309 Berwick Ct., Wake Forest, NC. stated she is in support of the Affordable Housing Plan.

Margaret Watkins at 407 Belmellen Ct., Wake Forest, NC stated the Affordable Housing Plan didn't give any priority to residents who have lived in Wake Forest for a lengthy period of time. She would like to see priority given to those residents.

Yolanda Taylor at 720 Rock Hill Rd., Wake Forest, NC said she supports the Affordable Housing Plan and asked the Board to approve the plan.

Mayor Jones asked if anyone else wanted to speak. No one came forward. Mayor Jones declared the public hearing closed.

Paige Van Lenten, President of the Wake Forest Senior Information Networking Group (SING) presented the Board of Commissioners with a resolution of appreciation for being key advocates for seniors and supporting the SING Group.

Dawn Nakash at 125 Barn Hill Rd., Wake Forest, NC is a community volunteer for multiple organizations. She applied for appropriate permits to hang banners for the charity car show and said the application is not user-friendly and believes it's geared

towards someone with a planning background. She said the fees are high and there are no waivers for non-profit organizations. She asks that the Board review the application and possibly develop a waiver for fees or make them more affordable for the non-profits in Wake Forest.

Ted Wilder at 934 -A Durham Rd., Wake Forest, NC is involved with the charity car show and agreed with what Ms. Nakash said about the fees. Mr. Wilder believes the fees should be waived because the money is going back into the community. Mr. Wilder also mentioned he received a violation notice about cars for sale on his property and a tenant of his received a notice about signage hung outside their business. He said it appears the ordinances are not small business friendly.

Rachel Macholl at 1228 Marbank St., Wake Forest, NC urged the Board to consider removing the condition pertaining to the street connection between Richland Hills and Rolling Acres and allow a second entrance/exit for the existing 234 homes for their safety.

Charlie (last name not provided) said he owns a business in Wake Forest and needs assistance with sign issues. He would like the Board to reconsider restrictions on placement of signs.

Mitchell (could not hear last name) spoke about an old town ordinance that says you're allowed to serve alcohol but cannot have more than three pool tables in the town. He would like to see the ordinance be put up for review. He's looking to bring more business into the Town of Wake Forest and has teamed up with the American Pool Players Association to possibly bring in a pool hall.

Yolanda Taylor congratulated the Town of Wake Forest for winning the 2022 American Planning Act - North Carolina Marvin Collins Award.

Mayor Jones asked if anyone else had any public comments. No one came forward to speak. Mayor Jones closed the public comment.
