3.A. Proclamation Recognizing the Month of October 2023 as "P.A.N.D.A.S. Month"

Mayor Jones read the proclamation into the record:

PROCLAMATION

RECOGNIZING OCTOBER 2023 AS "P.A.N.D.A.S. AWARENESS MONTH" IN THE TOWN OF WAKE FOREST, NORTH CAROLINA

WHEREAS, Pediatric Autoimmune Neuropsychiatric Disorders Associated with Streptococcal Infections, better known as PANDAS, is said to be a rare condition but is actually rarely diagnosed; and

WHEREAS, PANDAS is a term used to describe a subset of children who have Obsessive Compulsive Disorder and/or tic disorders such as Tourette Syndrome and in whom symptoms worsen following strep infections such as Strep Throat and Scarlett Fever; and

WHEREAS, children are often misdiagnosed and treatment is delayed. There are many treatments and options for treating this condition but, unfortunately, they are often very expensive and not covered by insurance;

WHEREAS, my friend Jay Jay Wilson suffers from this debilitating condition and I have been issuing proclamations for 10 years on his behalf; and

WHEREAS, Jay Jay's parents work so hard to provide everything he needs to live a good life; and

and urge all citizens to become aware of this debilitating condition for children and work to make it more readily recognized by the medical profession and insurance providers.

WHEREAS, many of North Carolina's 70 public power cities and towns have been electric providers for more than 100 years and provide 1.2 million citizens with safe, reliable power; and WHEREAS, North Carolina's public power utilities are dependable institutions that provide excellent service and a commitment to community and they are valuable community assets that contribute to the well-being of the community and provide economic development opportunities; and.

NOW, THEREFORE, I, Vivian A. Jones, Mayor of the Town of Wake Forest do hereby proclaim the week of October 1-7 the 37th annual Public Power Week, a week to promote North Carolina's public power cities and towns for their contributions to their communities; and urge all citizens of Wake Forest to join with all public power systems in the United States in this celebration of public power.

Commissioner Sary said this is a rare example of where the Town's Community Plan and the Future Land Use Map probably got it wrong. He understands the Planning Staff and the Planning Board's recommendation and appreciates that because it's based on the Community Plan. He said it's the Board's responsibility to look at each request and ask themselves if it makes sense. He stated the property is zoned General Residential-10, and as a use-by-right, you can have ten to twenty-five townhomes or apartments go there without any type of request from this Board. He said there's more of a buffer on this property than on the Heritage Property to the east and south. The applicant had worked with neighbors who expressed concern. Commissioner Sary thinks the appearance of the structure is not your typical 1980s or 1990s storage unit and will look like a Class A office. He said there's obviously a need for something like this for folks moving to the Town. He does not have any problems with the request and appreciates staff and the Planning Board's recommendation but thinks this is one that was maybe overlooked when putting the Town's Community Plan and Future Land Use Map together.

Commissioner Dyer stated based on the topography he agrees 100 percent.

12.B. Commissioner Reports

Commissioner Dyer attended the Citizens Academy and participated in the Memorial Flag Raising Ceremony. He reminded everyone that the next Memorial Flag Raising Ceremony is on Monday, October 2, 2023 at Town Hall Plaza. He participated in the POW/MIA Recognition Day Reading of the Names. He shared that the Tunnel to Towers Run & Walk is scheduled for Saturday, October 7, 2023.

Commissioner Wright attended Good Neighbor Day and was happy Jay Wilson won the youth award for Good Neighbor of the Year. He said some of the things people are doing in the Town's neighborhoods make him proud to be a commissioner for the Town of Wake Forest. He will be helping at the Tree Trail Trek Event at Joyner Park.

Commissioner Sliwinski thanked Chief Early and the Fire Department for putting on the September 11th Event last week. The Mental Wellness & Self Care Fair will take place on Saturday, October 21, 2023 from 1:00 to 4:00 p.m. at the Renaissance Centre. He attended the Memorial Flag Raising Ceremony.

Commissioner Shackleford attended the Memorial Flag Raising Ceremony, the 911 Service, and the Northeast Coalition Meeting.

Commissioner Sary shared that he kicked off FNOW. He said he enjoyed the Citizens Academy session and promoted Wake Forest's National Night Out scheduled on Monday, October 2, 2023 from 5:00 to 7:30 p.m.

Mayor Jones attended the Metro Mayor's Rail Work Group, NCDOT held a virtual update on the S-Line Coalition, she attended the Senior Expo, the Senior Information Networking Group held their five-year anniversary to celebrate being an official 501(c)(3) Organization, she attended the Makery Ribbon Cutting, she had lunch with Wake Forest Power Staff, and she attended the open house for S. Main St. planning.

Mayor Jones explained at the Board's last meeting she said it wasn't worth the time and money to go to Washington D.C. regarding Capital Blvd. and what she meant was she didn't think the Town should pay for any of the Board members to go at this time. She'd like to propose they not authorize the trip at this time and save it for a time that would benefit the Town's residents.

Commissioner Sary said they all want what's best for Wake Forest, but based on conversations he's had he doesn't think going to Washington D.C. would accomplish anything.

Commissioner Wright strongly disagrees. He said this Town has every right to know we're going to advocate for citizens. He said it's about building connections and relationships.

Commissioner Dyer asked how much a trip to Washington D.C. would cost. Mayor Jones replied \$1500 per person.

Commissioner Sliwinski said the trip is about more than just Capital Blvd. He said it's an opportunity for the Chambers to start making connections, and if they're asked to go, they should consider going in support of the Chamber. He suggested they continue to talk about the trip.

Commissioner Shackleford asked when it was scheduled. Commissioner Wright replied on October 24 and 25, 2023.

Commissioner Sary said he agrees with Commissioner Wright that they need to put themselves in the best light but if it's just a trip for Capital Blvd. it's not worth the time. Commissioner Wright replied that the Chamber doesn't want to go just for Capital Blvd. Commissioner Sary said he hasn't heard anything about this, and it's all been behind closed doors. Commissioner Sary remarked if the Chambers want to provide a presentation, he welcomes them to come talk to the Board. Commissioner Wright said there has been discussion about it but not in a public setting.

Commissioner Shackleford asked do we use Town funds to pay for representatives of the Town Board to go. Commissioner Shackleford asked where that falls under their budget. Town Manager Padget stated if the Town is paying for you to attend you would go in your official capacity as commissioner. Commissioner Sary asked if they could continue the discussion at the Work Session. Commissioner Sliwinski asked, based on the timing of the trip, would the Board have time to wait and discuss at the Work Session or should they reach out to the Chambers and get clarification on the agenda items. Mayor Jones said they would work on it and get the information to the Board. Town Manager Padgett said he would reach out to the Chambers and ask them for a revised agenda and talking points on what the meeting is about, and he'll invite Chamber Staff to the October 3, 2023 Board of Commissioners Work Session.

Town Manager Padgett said there was an issue with some of the legal ads for tonight, so those items will be scheduled for the October Work Session. He mentioned the Planning Board candidates who were voted on this evening would take office immediately due to trouble meeting quorum. Mr. Padgett said there are two Planning Board members whose terms expire at the end of the year who will not seek reelection, so the Board will act on those at a future date.

Town Manager Padgett stated that Executive Director Kristen Brannock of Resources for Seniors requested a meeting with Town Manager Padgett, Mayor Jones, and Assistant Town Manager Aileen Staples. He said the Senior Center is growing exponentially with programs, new participants, and members of the Senior Center. That coupled with some change of funding from the County and some redirection from the Resource for Seniors Board is going to cause an approximate \$50,000 deficit this year, and to balance that deficit they're going to look at cutting programs at the Senior Center. Town Manager Padgett asked before they cut any programs, he wanted to bring this to the Board of Commissioners to see if they'd be willing to take money out of their fund balance to fill that \$50,000 gap. Town Manager Padgett mentioned at the Board's Retreat in January

2024, they would discuss the future of the Senior Center and what that means for the Town. They will also discuss how to fund and operate the Senior Center going forward. Commissioner Wright said he recently had a conversation with folks about how much they loved the Senior Center. Commissioner Wright asked how it would affect the Town financially. Town Manager Padgett replied they'd be fine and could afford to do that.
