1. Presentations

1.1 Presentation on a rezoning filed by St. John's Episcopal Church to rezone 5.07± acres located at 834 Durham Road, being Wake County Tax PIN 1831721164, from General Residential 3 (GR3) to Highway Business (HB)

Senior Planner Kari Grace provided an overview of Case RZ-21-13, St. Johns' Episcopal Church located at 834 Durham Rd. This item is slated for public hearing at the Tuesday, February 15, 2022, Board of Commissioners Meeting.

Commissioner Sary stated the request makes sense and is consistent with the Town's Comprehensive Plan. He remarked it falls in line with the zoning around it, but do we need to review the town's sign regulations for these particular uses moving forward. Ms. Grace replied staff will evaluate the regulations as staff undertakes that process.

Bob Hill, 1017 Wilts Dairy Ct., member of the applicant team, spoke in favor of the request, citing the fundamental issue is to have a nice, larger monument sign that complies with the sign ordinance of Wake Forest. Mr. Hill stated the reasons they're requesting the rezoning is to have a larger sign and the pending Durham Road improvements having a major impact on the Episcopal Church.
