1. Presentations

1.1 Proclamation Recognizing September 28, 2022 as "Good Neighbor Day"

Mayor Jones stated the Proclamation recognizing Good Neighbor Day would be read Saturday, September 17, 2022 during the Good Neighbor Day event.

GOOD NEIGHBOR DAY PROCLAMATION

Whereas, the Human Relations Council was established to encourage understanding and good will between all citizens regardless of race, sex, religion, creed, family status, disability, nationality or economic status and thus promote the general welfare of the Town of Wake Forest; and

Whereas, the Human Relations Council holds its meetings at various locations to promote good relations in all areas and to afford as many citizens as possible the opportunity to attend such meetings; and

Whereas, the Human Relations Council wishes to sponsor meetings and forums intended to lead all citizens to a clearer understanding of the true meaning of responsible citizenship in the Town of Wake Forest, of the obligation inherent in being a good citizens and of the need for mutual understanding and respect by all citizens for each other.

Now, Therefore, I, Vivian A. Jones, Mayor of the Town of Wake Forest do hereby proclaim September 28, 2022 as "Good Neighbor Day" in Wake Forest and urge all citizens of Wake Forest to actively support and take pride in the worthwhile efforts of this organization and in the work of the Human Relations Council.

1.2 Presentation on CPA-22-02, Draft Town of Wake Forest Housing Affordability Plan:

Long Range Planning Manager Brad West provided the following background:

- Wake Forest's rapid growth has led to a significant increase in housing costs, affecting both existing and prospective residents.
- In 2020, the Wake Forest Board of Commissioners approved a .5 cent property tax increase to fund affordable housing initiatives in town.
- The Housing Affordability Plan is the first initiative supported by the proceeds of the .5 cent property tax increase.

Phillip Kash with HR&A Advisors provided an overview on the Housing Affordability Plan:

- Introduction & Planning Process
- Existing Conditions: Population Demographics
- Existing Conditions: Housing
- Community Engagement
- Taking Action (Implementation)

Commissioner Wright asked if there are any grants or non-profits that partner with towns. Mr. Kash suggested the following federal programs: Choice Neighborhoods Initiative, Rental Assistance Demonstration (RAD), and other programs through the State Housing Finance Agency.

Commissioner Sliwinski asked what's a typical reduction in price when there's a Community Land Trust. Mr. Kash responded you'd generally see about 100,000 to \$140,000 in public subsidy come into the deal.

Commissioner Dyer asked what source was used in the data received on the \$50,000 annual income disparity between new folks coming into town and residents currently residing there. Mr. Kash responded they get information from census data and the housing data comes from sources such as Zillow.

Mayor Jones asked about expanding and preserving home ownership. She said the easiest and least financially restrictive for the town would be to add land use policy changes. Mr. Kash said the land use piece will do the most for expanding access to home ownership. He said where it can't reach, as easy, is where there is disparity on access to mortgage financings or deeper levels of affordability.

Mayor Jones said the town will have infill development as time goes on. Mr. Kash remarked as long as you have a good design standard, they don't hurt a neighborhood.

Commissioner Shackleford stated he liked the implementation part of the program but thinks the issue is going to have to be multifaceted in the approach. How do you stop people from coming in and buying at a low price and turning them into rental homes. Commissioner Shackleford said it's going to have to be a conscious effort to balance the strategies to get to the goal.

A public hearing on the Housing Affordability Plan is scheduled for Tuesday, September 20, 2022.

4. Other Business

Public Hearing on LEGISLATIVE CASE RZ-21-09, Hawthorne Wake Forest Phase 2, a rezoning filed by Evolve Companies to rezone 5.83± acres located at 0 Star Road, being Wake County Tax PIN 1739662623, from Highway Business (HB) to General Residential 10 Conditional District (GR10-CD).

Tonya Powell at 4141 Parklake Ave., Suite 200, Raleigh, NC 27612 stated it's a unique piece of property sandwiched between the apartment complex that's currently under construction and the City of Raleigh property. Ms. Powell presented aerial photographs of the site. Ms. Powell realizes it's not consistent with the Community Plan but believes it's a reasonable request. She stated, based on the buffers, only about 3-acres are useable and is unlikely to be a commercial development. She stated it may not be consistent with the plan but it's consistent with the neighboring use.

Traffic Engineer Patrick Perez with NV5 Engineer Consultants, 3103 Whitehart Ln, Apex, NC 27539 provided information about the connectivity, amenities, and open space of the proposed site. Mr. Perez indicated the location would be very tough for commercial use due to limited access of the building and visibility.

Jeff Weller with Stantec Consulting Services, 801 Jones Franklin Rd., Raleigh, NC 27606 spoke about the current access from US 1 to Star Rd. He stated with the NCDOT project the quick access will go away and become difficult to navigate.

Commissioner Dyer asked how many additional families from Phase 2 will be using the amenities in Phase 1. Mr. Perez responded there's a total of 56 units for Phase 2.

Ms. Powell stated when the amenities were designed and built, they were designed oversized in anticipation that the project would be built. Ms. Powell stated the proposed project is consistent with the adjoining property and will encourage pedestrians and bicyclists in moving around the neighborhood, which could be a problem if it were commercial use. Ms. Powell said it promotes walkability and sidewalk use.
