**PROCLAMATION**  
**RECOGNIZING OCTOBER 2025 AS "P.A.N.D.A.S. AWARENESS MONTH" IN THE**  
**TOWN OF WAKE FOREST, NORTH CAROLINA**

**WHEREAS, Pediatric Autoimmune Neuropsychiatric Disorders Associated with Streptococcal Infections, better known as PANDAS, is said to be a rare condition but is actually rarely diagnosed; and**

**WHEREAS, PANDAS is a term used to describe a subset of children who have Obsessive Compulsive Disorder and/or tic disorders such as Tourette Syndrome and in whom symptoms worsen following strep infections such as Strep Throat and Scarlet Fever; and**

**WHEREAS, children are often misdiagnosed and treatment is delayed. There are many treatments and options for treating this condition but, unfortunately, they are often very expensive and not covered by insurance;**

Development Services Manager Patrick Reidy advised of the applicant's request for a continuance of the public hearing on Legislative case RZ-24-07 to the Board of Commissioners' November 6<sup>th</sup> work session. Mr. Reidy advised the request is due to a study being conducted on the backage road to determine the capacity needs to warrant the road or if Star Road can handle the traffic.

Mayor Jones clarified that the public hearing was noticed, and the hearing will continue. Mr. Reidy confirmed the public hearing was noticed and the applicant wants a continuance to November 6<sup>th</sup>.

Commissioner Wright apologized for his absence at the September 2<sup>nd</sup> work session as he was on vacation. Commissioner Wright advised he attended the last Friday Night on White ("FNOW") and it was an amazing season of FNOW. Commissioner Wright acknowledged the tension felt in the community and reminded everyone there is no place for violence. Commissioner Wright advised he supports the LGBTQ neighbors and advised there is room to both disagree and be respectful. Commissioner Wright reminded everyone that they are all neighbors, that they all matter, and that they all have a view.

Commissioner Shackleford advised of no report.

Commissioner Cross extended appreciation to the speakers at the meeting and all of the communication received over the past week. Commissioner Cross extended condolences to the Lucas family following the tragic loss of Ericka Lucas. Commissioner Cross encouraged everyone to watch the Candidates Forum. Finally, Commissioner Cross advised that she attended the first class of the Citizens Academy.

Commissioner Clapsaddle extended appreciation and well wishes to Sergeant Charles Babson and his family for his 25 years of service. Commissioner Clapsaddle reminded everyone of "Good Neighbor Day" on Saturday, September 20<sup>th</sup> at Joyner Park where Mayor Jones will be presenting the Youth and Adult Neighbor of the Year award. Commissioner Clapsaddle advised the final Memorial Flag Raising will be on October 6<sup>th</sup>. Commissioner Clapsaddle advised the deadline for the Advisory Board application is September 30<sup>th</sup>. Finally, Commissioner Clapsaddle extended appreciation to all those that spoke during Public Comments and encouraged them to always listen and participate because that is what democracy is about.

Commissioner Sliwinski advised he neglected to mention the Central Pines Regional Council meeting two weeks ago where the Director of the upcoming NC Children's Hospital gave an update. Duke Health and UNC are joining forces to build North Carolina's only freestanding Children's Hospital anchored by a 500 bed hospital, ambulatory surgical center, medical office building and the only NC freestanding Adolescent Behavioral Health Hospital. This is a seven-year project that will produce 8400 jobs. Commissioner Sliwinski advised the Mental Wellness Fair is on September 27<sup>th</sup> from 1 p.m. to 4 p.m. with the keynote speaker presenting on the effects of social media and its impact on the developing brain. Commissioner Sliwinski advised there will also be a panel discussion that will include Eric and Terry Murray of the Grace and Murray Foundation. Commissioner Sliwinski advised there will be great resources, breakout rooms, and licensed therapists onsite, if needed.

Mayor Jones extended appreciation to the staff of Parks and Recreation Advisory Board for Wake Forest Unplugged. Mayor Jones advised the concerts in the park were great.

Mayor advised she attended the Garba Dance at Joyner Park, which is a ceremonial dance done by our Indian neighbors in Wake Forest. Mayor Jones advised she spent the morning with a group of kindergarteners, and it was a wonderful time.

Town Manager Kip Padgett confirmed that the Agenda Item 4A request to continue the Public Hearing is for November 6<sup>th</sup> and not the next meeting on October 7<sup>th</sup>.

Mayor Jones addressed the recent shootings in the Town and the country over the past week and acknowledged the difficulty for the community. Also, Mayor Jones addressed the fallout from the proposed LGBTQ+ History Month Proclamation and advised that she hopes this can be put to rest and move forward with trying to be the inclusive community that we all want to be.


